TRUST DEED

THIS DEED OF DECLARATION OF TRUST made at Delhi this 10<sup>th</sup> day of JUNE, 2008 between SHRI SIVA PRASAD SIVASUBRAMANIAM, NADAR (popularly known as "Shiv Nadar" and hereinafter referred to as such) son of Shri Sivasubramaniya Nadar, residing at No. 44, Friends Colony, (East), New Delhi (hereinafter also referred to as the "Founder", which expression shall, where the context so permits, be deemed to include his executors, administrators, heirs and successors in interest) of the ONE PART;

AND

1. Shri SHIV NADAR, son of Late Shri Sivasubramaniya Nadar, aged about 63 years, residing at No. 44, Friends Colony (East), New Delhi-110 065;
  2. Mrs. KIRAN NADAR, wife of Shri Shiv Nadar, aged about 57 years, residing at No. 44, Friends Colony (East), New Delhi-110 065;
- (hereinafter collectively called the "Trustees", which expression shall include the Trustee(s) from time to time of the Trust) of the OTHER PART.

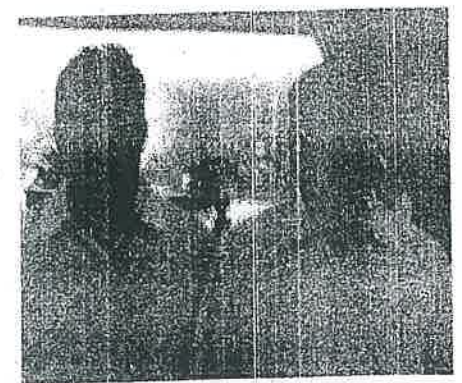
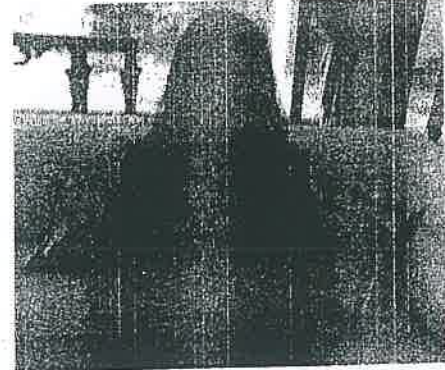

AND WHEREAS the **Founder** has set apart Rs.1001/- (Rupees One Thousand One only) as the nucleus of the fund for the **Trust**;

AND WHEREAS the **Trustees** aforesaid have agreed to act as the trustees of the **Trust** in accordance with the terms and conditions hereinafter appearing.

NOW THIS DEED WITNESSETH as follows:

(1)(a) The **Trust** shall mean the trust hereby created by this Deed of Declaration of **Trust** which shall include all amendments lawfully made to the Deed of Declaration of **Trust**.

(b) The name of the **Trust** shall be "**SHIV NADAR FOUNDATION**", which name cannot be changed or altered except by the **Founder**.

2. The office of the **Trust** shall in the first instance be situated at No. 44, Friends Colony (East), New Delhi-110 065. It shall be open to the **Trustees** to shift the office of the **Trust** to such other location(s) as may be determined by the **Trustees** from time to time.

### 3. **Trust Property**

(i) The **Founder** for effectuating the aforesaid desire, and in consideration of the terms stated herein doth hereby set apart, endow, give, grant, make over and deliver to the **Trustees**, the said sum of Rs.1001/- (Rupees One Thousand One only) to form the nucleus and corpus of the property and fund of the **Trust** (the receipt whereof the **Trustees** do hereby admit and acknowledge). The **Trust** possesses, at present, no immovable property, but is free to purchase or otherwise acquire the same or the use thereof in accordance with law.

(ii) The funds and properties of the **Trust** (hereinafter collectively referred to as the "**Trust Property**" or the "**Trust Fund**") shall comprise of:

- (a) The said sum of Rs. 1001 (Rupees one thousand one only).
- (b) The assets and properties whatsoever (movable and immovable) as may hereafter be acquired by the **Trust** by purchase or otherwise for the purposes of the **Trust**.

(c) All voluntary donations, gifts, legacies or grants in cash or in kind accepted by the **Trustees**, either as corpus or as income.

## 9. TRUSTEES:

(A) (i) Ms. Roshni Nadar, daughter of the **Founder**, be and is hereby appointed as a **Trustee** of the **Trust** in addition to the Trustees specified hereinabove. Consequently, the present Trustees of the **Trust** are the following members from the **Founder's Family**:

1. Shri Shiv Nadar (**Founder**);
2. Mrs. Kiran Nadar;
3. Ms. Roshni Nadar

(ii) The number of Trustees shall be not more than five (5).

(iii) (a) Subject to the provisions of Clause 9(A) (iv) hereof, as long as there shall exist sufficient members of the **Founder's Family** capable of and willing to act as trustees, at least three (3) trustees shall be persons belonging to the **Founder's Family**.

(b) Trustees belonging to **Founder's Family** shall have the power to unanimously increase the number of **Trustees** upto five (5), including by the appointment as **Trustee(s)** of persons from outside the **Founder's Family** in accordance with the provisions hereof. However, at no time shall the number of **Trustees** from outside the **Founder's Family** be equal to or exceed the number of **Trustees** belonging to the **Founder's Family**.

(iv) If there shall not be in existence at any time a Member of the **Founder's Family** who has attained the age of 21 (Twenty One) years and who is willing to act as **Trustee**, but there shall exist one or more members of the **Founder's Family** who have not attained such age, then until there shall exist a member of the **Founder's Family** who has attained the age of 21 years and is willing to act as trustee, there shall be three (3) **Trustees** of the **Trust** who shall be nominated by the Chairman of the HCL Corporation Limited at the relevant time, and in the absence of a Chairman, shall be nominated by the Managing Director of HCL Corporation Limited, and in the absence of a Managing Director, shall be nominated by the CEO of HCL Corporation Limited (by whatever name called). Such Chairman/Managing Director/CEO shall be entitled to nominate himself or herself as **Trustee**. The three **Trustees** so appointed shall jointly manage the affairs of the **Trust** till the minor from the **Founder's Family** attains the age of 21 (twenty one) years and has become a **Trustee** of the **Trust**.

18. The Trustees shall be kept fully indemnified and harmless by the Trust, against any loss or liability arising against them, for anything done by them in the good faith, pursuant to the powers and authority conferred on them by these presents.

19. The Trust hereby created is irrevocable.
